ELIGIBILITY REQUIREMENTS for COLLEGE FRESHMAN

To be eligible for the scholarship, you must:

- ❖ Be a first time college freshman residing in the United State
- ❖ Be enrolled in a degree-seeking program at an accredited two-year or four-year college or university (enrollment is verified)
- ❖ **NYEFS \$2,500 - \$5,000 Scholarship:** *Have a minimum cumulative grade point average (GPA) of 3.5 on a 4.0 scale (or the equivalent) and enrolled in a four-year college or university*
- ❖ **NYEFS \$500 - \$1,500 Scholarship:** *Have a minimum cumulative grade point average (GPA) of 3.0 on a 4.0 scale (or the equivalent) and enrolled in a two-year or four-year college*

SELECTION CRITERIA

Applicants are evaluated on the following criteria:

- ❖ Academic record
- ❖ Financial need (for educational purposes)

APPLICATION PREPARATION

- 1) **Application** (3 pages) – We strongly encourage you to type your application as it makes it easier for our selection committee to read; however, if you do not have a typewriter, you may neatly print the application in blue or black ink. Use the official application form or a photocopy of the form. Answer all questions.
- 2) **Transcript** – Provide a transcript from your current college / university.
 - ❖ Transcript must include a cumulative GPA and the scale of the GPA ranking. If your transcript does not show a cumulative GPA, request that a college official confirm the information on a college letterhead with his or her signature.
 - ❖ Transcript must have the name of your college / university and your name, Social Security number, and date of birth.
- 3) **Financial Information Documentation** – The following documents are essential to the processing of your application.
 - ❖ If you applied for federal financial aid, include a copy of Student Aid Report (SAR).
Note: Be sure to apply early for federal student aid at www.fafsa.ed.gov.
 - ❖ If you have not applied for federal financial aid, include a copy of your 1040, 1040 EZ, or 1040A federal tax return and W-2 form(s). Also include copies of your parents' (and spouse's, if married) federal income tax return(s) and W-2 form(s).

SEMIFINALISTS ONLY

- 1) **Short Essay** (2 pages only): My career goal inspirations and aspirations, describing your personal strengths, including motivation, leadership, and commitment.
The letter should address all following topics:
- 2) **Letters of Recommendation** – This must be from a teacher or advisor. The letter must be current and may not be from a relative. Allow your recommender at least one week to complete your recommendation. The letter must be confidential. Ask your recommender to return the recommendation letter to you in a sealed envelope with his or her signature written across the seal.
 - ❖ Academic record
 - ❖ Academic plans and career goals
 - ❖ Personal strengths, including motivation, leadership, and commitment
 - ❖ Community service and extracurricular activities

Transcript – See *Application Instructions* for details. (If applicable, attach copy of SAT or ACT scores).

Financial Information Documentation – a copy of all pages of your 2007 Student Aid Report (SAR) **OR**, if you did not apply for federal financial aid, copies of your and your parents' (and spouse's, if married) federal income tax return(s) and W-2 form(s). See *Application Instructions* for details.

Enclose Application Processing Fee – Make check or money order in the amount of \$20.00, payable to **New York Education Foundation**. Attach with paper clip (NO STAPLES) to the signature page of the application.
